**Why join the Society?**

As a member of the Society you will receive regular Newsletters and the Bulletin "Mining History", as well as special offers on other new publications. Members are invited to attend Society meetings, field trips, both surface and underground, conservation meetings and work parties. Exploration of mines in the area is carried out by small groups of members supported by the Society. Introductions to these groups can be arranged. Members have free access to the Peak District Lead Mining Museum and Temple Mine at Matlock Bath and reduced accommodation fees at the Magpie Mine Field Centre.

When you join the Society you will become a shareholder in the **Peak District Mines Historical Society Limited** (the Company). Your liability in the event of the Company being wound up is limited to £1.00. Your signature on the Application Form indicates your agreement to this.

The Society Newsletters are published four times a year, in January, April, July and October. "Mining History", the Society's Bulletin, is normally published twice a year and distributed with the April and October Newsletters.

Lectures and slide or film shows are usually held at the Peak District Lead Mining Museum in the Grand Pavilion, Matlock Bath.

The Museum and Magpie Field Centre are also available for other events. The Annual General Meeting and associated Social Events are held in November, usually at the Peak District Lead Mining Museum.

The Membership Rates shown apply to the United Kingdom. Overseas applicants paying in local currency should ensure that their payments will yield the due amount after deduction of all exchange rate charges.

Members paying UK Taxes are requested to register for Gift Aid on the enclosed declaration. The Society may then claim back 25% of their subscriptions, and subsequent payments made by them, from HMRC.

**Members' Insurance**

Society members are covered by a PDMHS insurance policy which gives third party cover whilst engaged on Society approved mining history activities or representing PDMHS at other organised events. This is **NOT** a personal accident policy and does not cover independent or commercial activities. # The General Data Protection Regulation 2018

## PDMHS Privacy Statement

This statement is drafted to comply with the General Data Protection Regulation 2018 (GDPR). Members should note that the requirements of the GDPR do not require any change in the Society’s policies or practices compared to the preceding Data Protection Act 1988.

The GDPR requires the Society to clearly state the “Legal Basis” for its obtaining, holding and using personal data. By becoming a member of the Society you enter into a contract with the Society in which you agree to pay a subscription to the Society and abide by the conditions of membership, and the Society agrees to provide to you the benefits of membership, such as publications, free access to the Peak District Lead Mining Museum, field trips and access to the privileged members’ area of the website.

Article 6(1)(b) of the GDPR states that “processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract”. The Society’s Legal Basis is as under this Article.

The performance of this contract ensures that members are not required to give explicit consent for such use of their data, and also cannot object to or prevent its use without terminating their membership. Members have the right to request a copy of the data held on them, to have errors in the data corrected, and to request deletion of the data after the termination of their membership.

The personal data, defined as data by which an individual may be identified, held by the Society consists of the names of members including both adult members and any under-18 members in Joint or Family membership, postal addresses, and telephone numbers and email addresses (if provided by the member). No data which is classified as “Sensitive” or “Special category Data” by the GDPR is held by the Society.
